I. PRICING AND PERIOD OF PERFORMANCE

The Contractor shall perform standard trash removal services at the U.S. Embassy Compound as listed in section I.19 Locations of All Services. The prices listed below shall include all labor, materials, equipment, services, insurance (see FAR 52.228-3 and 52.228-5), overhead, and profit. The Government will pay the Contractor the fixed price per month for Standard Services that have been satisfactorily performed.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from start date listed in Notice to Proceed unless the Contractor agrees to an earlier date) on which performance shall start.

The performance period of this contract is from the start date in the Notice to Proceed and continuing for 12 months, with four one-year options to renew. The initial period of performance includes any transition period authorized under the contract.

I.1.1. VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices as the U.S. Embassy has a tax exemption certificate from the host government.

DESCRIPTION / SPECIFICATIONS / WORK STATEMENT

I.2 SCOPE OF WORK

The purpose of this fixed-price contract is to obtain refuse, waste, trash and debris removal services from the U.S. Embassy compound at Soba, Khartoum, Sudan, as listed in section II.18 Locations of All Services.

The Contractor shall furnish all managerial, administrative, and direct labor personnel that are necessary to accomplish the work in this contract. Contractor employees shall be on site only for contractual duties and not for other business purposes.

I.3 GENERAL REQUIREMENTS

The removal of all trash, refuse, waste and debris from the U.S. Embassy Compound are an important part of the representational and health and safety responsibilities of the U.S. mission. The U.S. Government will measure the Contractor's work by the general appearance of the trash collection site. The Contractor shall perform complete waste, trash, debris removal services as described in this contract for all Government properties listed in section II.18 Locations of All Services. The Contractor shall provide and include all personnel, equipment, planning, administration, and management necessary to assure that all services comply with the contract, the COR's schedules and instructions, and all applicable laws and regulations. The Contractor shall meet all of the standards of performance identified in the contract. The Contractor shall perform all related support functions such as supply, subcontracting, quality control, financial oversight, and maintenance of complete records and files. The contractor shall prepare general instructions for the work force.

I.4 Duties and Responsibilities

- I.4.1. Contractor shall collect Trash from the U.S. Embassy Compound on pre-determined days, three (3) times per week, from designated trash containers at collection sites on the compound.
- I.4.2. Trash: Trash containers may include garbage, debris, garden / yard waste, organic waste, boxes, containers, etc. All trash is to be removed from each trash container.
- I.4.3. Container Cleanliness. The contractor shall ensure that all trash containers are free of all trash upon completion of work. Loose trash must be removed and disposed of during scheduled pickups. Contractor shall ensure odors from dirty containers are prevented.
- I.4.4. Spillage. The Contractor shall pickup all spillage around collection sites within a ten (10) foot radius. The cleanup operation shall be concurrent with scheduled collections. The Contractor shall ensure that vehicle bodies are kept covered at all times to prevent loose trash from blowing off.

I.5 MANAGEMENT AND SUPERVISION

- I.5.1. SUPERVISION. The Contractor shall designate as many supervisors as necessary, but at least one, who shall be responsible for on-site supervision of the Contractor's workforce at all times. These supervisors shall be the focal point for the Contractor and shall be the point of contact with U.S. Government personnel. The supervisor shall have sufficient English language skill to be able to communicate with members of the U.S. Government staff. At the end of each working day, the supervisor shall inspect all work areas to confirm that all necessary work was completed in a correct way.
- I.5.2. SCHEDULES. The Contractor shall maintain work schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of the Post. The Contractor shall deliver standard services between the hours of 7:00 AM and 4:30 PM Sunday through Thursday. For those items other than routine daily services, the Contractor shall provide the COR with a detailed plan as to the personnel to be used and the time frame to perform the service.
- I.5.3. QUALITY CONTROL. The Contractor, not the Government, shall be responsible for quality control and meeting of the terms of this contract. The Contractor shall perform inspection visits to the work site on a regular basis. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved, and the COR will conduct surprise inspections.

I.6 MATERIALS AND EQUIPMENT. The Contractor shall provide all necessary trash removal supplies and equipment, including but not limited to vehicles, containers / bags, ladders, brooms, uniforms, gloves, shoes, etc. to perform the work identified in Section II. The contractor is advised to use any kind of equipment that is approved by the city administration and is safely used for job performance.

I.7 ACCESS.

I.7.1. The trash collection points are inside the U.S. Embassy Compound and proper access must be granted.

I.8 WORKING HOURS. All work shall be performed on the three pre-determined days, Sunday – Thursday from 7:00AM to 4:30PM except for the holidays identified in the Section II: Contract Clauses 652.237-72. Other hours may be approved by the COR. The Contractor must provide at least 24-hour advance notice to the COR who will consider any deviation from the hours identified above.

I.9 DELIVERABLES. The following items shall be delivered under this contract:

I.10 INVOICES AND PAYMENT: The Contractor shall provide a monthly invoice to the COR detailing all work completed. After routine inspections by the COR, if all work is deemed to be performed according to this contract, the invoice will be paid within 30 days from the date of invoice submission.

I.11 PERSONNEL REQUIREMENTS.

I.11.1. The U.S. Government is committed to promoting the fair and equitable treatment of all workers. In addition to adherence to the laws and regulations stated in I.17, the Contractor must pledge to be socially responsible by providing wages, benefits, and ethical treatment to its employees that go beyond the minimum required by local law, and demonstrate a commitment to a work environment befitting of a company contracted by the U.S. Government.

I.11.2. In an effort to not displace current employees working on U.S. Government property and to take advantage of their acquired knowledge and security access, the Contractor agrees to offer employment to as many of the former contractor's employees as is possible.

I.11.3. The Contractor shall employ sufficient personnel to maintain appropriate staff levels at all times. The Contractor shall have on reserve adequate personnel to cover any absences, ensuring there is no break in or deterioration of service at any location.

I.11.4. Contractor employees shall be on site only for duties related to this contract and not for any other business purposes. The Contractor shall maintain discipline at the site and shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by Contractor employees at the site. The Contractor shall preserve peace and protect persons and property on site. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional expense to the Government.

I.12 STANDARD OF CONDUCT

I.12.1. Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty. All employees shall wear uniforms approved by the COR that clearly identify them as employees of the Contractor.

I.12.2. Neglect of duties shall not be condoned. The Contractor shall enforce no sleeping while on duty and ensure that unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security are not tolerated.

- I.12.3. Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities, which interfere with normal and efficient Government operations.
- I.12.4. Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.
- I.12.5. Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:
 - i Falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;
 - ii Unauthorized use of Government property, theft, vandalism, or immoral conduct;
 - iii Unethical or improper use of official authority or credentials;
 - iv Security violations; or,
 - v Organizing or participating in gambling in any form.

- I.13 KEY CONTROL. The Contractor shall receive, secure, issue and account for any keys issued for access to buildings, offices, equipment, gates, etc., for the purposes of this contract. The Contractor shall not duplicate keys; if duplicate keys are needed, the COR will provide. Where it is determined that the Contractor or its agents have duplicated a key without permission of the COR, the Contractor shall remove the individual(s) responsible from this contract. If the Contractor has lost any such keys, the Contractor shall immediately notify the COR. In either event, the Contractor shall reimburse the Government for the expense of rekeying that portion of the system.

- I.14 NOTICE TO THE GOVERNMENT OF LABOR DISPUTES. The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

- I.15 PERSONNEL SECURITY
 - I.15.1. Five (5) days after award of the contract, the Contractor shall provide the following list of data on each employee who will be working under the contract. The Contractor shall include a list of workers and supervisors assigned to this project, including enough alternates. The Government will run background checks on these individuals. It is anticipated that security checks will take approximately 60 days to perform. For each individual the list shall include:
 - Full Name
 - Place and Date of Birth
 - Current Address
 - National Identification number
 - I.15.2. Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identity card(s) on the uniform at all times while providing services under this contract. These identity cards are the property of the US Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of the Government. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual. In the event that an identity card is lost or stolen, the COR must be informed immediately.

- I.16 INSURANCE
 - I.16.1. AMOUNT OF INSURANCE. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:
 - I.16.2. GENERAL LIABILITY (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)
 - i Bodily Injury (stated in US Dollars):

- I.16.3. The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.
- I.16.4. For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3, or host country nationals that do not have a DOL waiver.
- I.16.5. The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to any property of the Contractor, its officers, agents, servants, employees, or any other person, arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.
- I.16.6. The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.
- I.16.7. Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State," as an additional insured with respect to operations performed under this contract.
- I.16.8. Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

I.17 LAWS AND REGULATIONS

- I.17.1. Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. If there is a conflict between the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.
- I.17.2. The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, unless they are inconsistent with the requirements of this contract.

I.18 TRANSITION PLAN. Within 7 days after contract award, the Contracting Officer may develop a plan for preparing the new Contractor to assume all responsibilities for gardening services. The plan shall establish the projected period for completion of all clearances of contractor personnel, and the projected start date for performance of all services required under this contract. The plan shall assign priority to the selection of all supervisors to be used under the contract.

- I.18.1. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP). This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.
- I.18.2. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
- I.18.3. STANDARD. The performance standard is that the Government receives no more than one (2) customer complaints per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.
- I.18.4. PROCEDURES.
 - i If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
 - ii The COR will complete appropriate documentation to record the complaint.
 - iii The COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

- iv If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- v The COR shall, at a minimum, orally notify the Contractor of any valid complaints.
- vi If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- vii The COR will consider complaints as resolved unless notified otherwise by the complainant.
- viii Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(4) Earth-moving equipment and other large vehicles;

(5) Cranes and rigging;

(6) Welding or cutting and other hot work;

(7) Partial or total demolition of a structure;

(8) Temporary wiring, use of portable electric tools, or other recognized electrical hazards. Temporary wiring and portable electric tools require the use of a ground fault circuit interrupter (GFCI) in the affected circuits; other electrical hazards may also require the use of a GFCI;

(9) Work in confined spaces (limited exits, potential for oxygen less than 19.5 percent or combustible atmosphere, potential for solid or liquid engulfment, or other hazards considered to be immediately dangerous to life or health such as water tanks, transformer vaults, sewers, cisterns, etc.);

(10) Hazardous materials - a material with a physical or health hazard including but not limited to, flammable, explosive, corrosive, toxic, reactive or unstable, or any operations, which creates any kind of contamination inside an occupied building such as dust from demolition activities, paints, solvents, etc.; or

Work shall not begin until the AHA for the work activity has been accepted by the COR and discussed with all engaged in the activity, including the Contractor, subcontractor(s), and Government on-site representatives.

(3) The names of the Competent/Qualified Person(s) required for a particular activity (for example, excavations, scaffolding, fall protection, other activities as specified by EM 385-1-1) shall be identified and included in the AHA. Proof of their competency/qualification shall be submitted to the contracting officer or COR for acceptance prior to the start of that work activity. The AHA shall be reviewed and modified as necessary to address changing site conditions, operations, or change of competent/qualified person(s).

Observance of such days by Government personnel shall not be cause for additional period of performance or entitlement to compensation except as set forth in the contract. If the contractor's personnel work on a holiday, no form of holiday or other premium compensation will be reimbursed either as a direct or indirect cost, unless authorized pursuant to an overtime clause elsewhere in this contract.

(c) When the Department of State grants administrative leave to its Government employees, assigned contractor personnel in Government facilities shall also be dismissed. (i) The Offeror (itself or through its immediate owner or highest-level owner) does, does not publicly disclose greenhouse gas emissions, *i.e.*, makes available on a publicly accessible website the results of a greenhouse gas inventory, performed in accordance with an accounting standard with publicly available and consistently applied criteria, such as the Greenhouse Gas Protocol Corporate Standard.

(ii) The Offeror (itself or through its immediate owner or highest-level owner) does, does not publicly disclose a quantitative greenhouse gas emissions reduction goal, *i.e.*, make available on a publicly accessible website a target to reduce absolute emissions or emissions intensity by a specific quantity or percentage.

(iii) A publicly accessible website includes the Offeror's own website or a recognized, third-party greenhouse gas emissions reporting program.

(3) If the Offeror checked "does" in paragraphs (t)(2)(i) or (t)(2)(ii) of this provision, respectively, the Offeror shall provide the publicly accessible website(s) where greenhouse gas emissions and/or reduction goals are reported:_____.

(u)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) *Representation.* By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (*e.g.*, agency Office of the Inspector General).
